## **Safety Tips**

- Position on a flat, stable surface.
- A service agent/qualified technician should carry out installation and any repairs if required.
- Consult Local and National Standards to comply with the following:
  - Health and Safety at Work Legislation
  - BS EN Codes of Practice
  - Fire Precautions
  - IEE Wiring Regulations
  - Building Regulations
- DO NOT immerse the appliance in water, or use jet/pressure washers to clean the appliance.
- DO NOT allow oil or fat to come into contact with the plastic components or door seal. Clean immediately if contact occurs.
- DO NOT store products on top of the appliance.
- Always carry, store and handle the appliance in a vertical position and move by holding the base of the appliance.
- Always switch off and disconnect the power supply to the appliance when not in use.
- Not suitable for outdoor use.
- Keep all packaging away from children. Dispose of the packaging in accordance to the regulations of local authorities.
- If the power cord is damaged, it must be replaced by a POLAR agent or a recommended qualified technician in order to avoid a hazard.
- This appliance is not intended for use by persons (including children) with reduced physical, sensory or mental capabilities, or lack of experience and knowledge, unless they have been given supervision or instruction concerning the use of the appliance by a person responsible for their safety.



- Children should be supervised to ensure that they do not play with the appliance.
- POLAR recommend that this appliance should be periodically tested (at least annually) by a Competent Person. Testing should include, but not be limited to: Visual Inspection, Polarity Test, Earth Continuity, Insulation Continuity and Functional Testing.
- POLAR recommend that this product is connected to a circuit protected by an appropriate RCD (Residual Current Device).

## **Caution: Risk of fire / Flammable materials**



 Do not store explosive substances such as aerosol cans with a flammable propellant in this appliance.



Warning: Keep all ventilation openings clear of obstruction. Unit should not be boxed in without adequate ventilation.

- **Warning:** Do not use mechanical devices or other means to accelerate the defrosting process, other than those recommended by the manufacturer.
- Warning: Do not damage the refrigerant circuit.
- Warning: Do not use electrical appliances inside the food storage compartments of the appliance, unless they are the type recommended by the manufacturer.



#### **Installation**

Note: If the appliance has been stored or moved in a non-vertical position, stand it in an upright position for approximately 12 hours before operation. If in doubt allow to stand.

- Remove the appliance from the packaging and remove the protective film from all surfaces.
- When positioning, maintain a distance of 10cm between the appliance and walls or other objects for ventilation. NEVER LOCATE NEXT TO OR NEAR A HEAT SOURCE.
- To avoid being pushed tight against the wall accidentally and ensure good ventilation, 2 spaces are supplied for mounting on the rear.




4. If necessary, adjust the screw feet of the appliance to make it level.

Note: Before using the appliance for the first time, clean the shelves and interior with soapy water.
Shelf load (Max.): 10kg

## **Operation**

#### **Control panel**



**	Refrigerant LED: During refrigerating, LED is on; When the set temperature is reached and constant, LED is off.
***	Defrost LED: During defrosting, LED is on; When defrosting finishes, LED is off.
Â	Up Button
<u></u>	Down Button
<b>*</b>	Manual defrost button / light button
SET	Set button

#### **Adjusting the Temperature**

- Press SET button. The set temperature is displayed.
- 2. Press up button a or down button to change set temperature.
- 3. Press SET button to exit.

#### Internal light

Press the button on the controller to turn the internal light on/off.

#### Glass heater function

Set the switch to desired setting when necessary.

#### **Manual Defrost**

#### **Controller reset**

- 1. When the display shows "Disorder', press for 2 seconds until the appliance beeps.
- Quickly press <u>a</u> for 6 seconds until the appliance beeps again.
- The display will flash for 3 seconds then restore factory settings.

#### Tips for use:

To get the best results from your POLAR appliance, follow these instructions:

- Do not put oily food, solidified liquid food, frozen food, etc. directly on the inner wire rack and bottom of the machine, so as to avoid oil or other liquid flowing into the machine base, which will affect the normal operation and even damage the machine. It is recommended to put food on the tray to avoid dripping oil or other residues.
- Wrap or cover food where possible.
- Do not obstruct the vents inside the appliance.
- Avoid opening the door for prolonged periods of time.

## Cleaning, Care & Maintenance



Switch off and disconnect from the power supply before cleaning.

- Clean the interior of the appliance as often as possible.
- Do not use abrasive cleaning agents. These can leave harmful residues.
- · Always wipe dry after cleaning.
- Carry out a manual defrost if excessive ice is present.
- Remove any water that may be present before usage.

#### **Cleaning the Condenser**

Periodic cleaning of the Condenser can extend the life of the appliance.

POLAR recommend that a POLAR agent or qualified technician clean the condenser.

## **Troubleshooting**

If your POLAR appliance develops a fault, please check the following table before making a call to the Helpline or your POLAR dealer.

## **Electrical Wiring**

POLAR appliances are supplied with a 3 pin BS1363 plug and lead.

The plug is to be connected to a suitable mains socket.

POLAR appliances are wired as follows:

- Live wire (coloured brown) to terminal marked L
- Neutral wire (coloured blue) to terminal marked N
- Earth wire (coloured green/yellow) to terminal marked E

This appliance must be earthed.



If in doubt consult a qualified electrician.

Electrical isolation points must be kept clear of any obstructions. In the event of any emergency disconnection being required they must be readily accessible.

## **Disposal**

EU regulations require refrigeration product to be disposed of by specialist companies who remove or recycle all gasses, metal and plastic components.

Consult your local waste collection authority regarding disposal of your appliance. Local authorities are not obliged to dispose of commercial refrigeration equipment but may be able to offer advice on how to dispose of the equipment locally.

Alternatively call the POLAR helpline for details of national disposal companies within the EU.
